

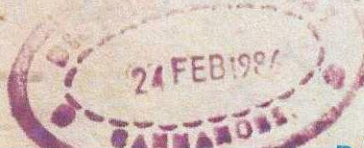

WHEREAS in pursuance of a common intention among the founders to establish educational, Cultural and Charitable trust for the economic uplift, Cultural and educational needs of the needy, indigent, destitutes and weaker section of the people as also for dissemination of Knowledge on ethics and morality for observance and practice by the people irrespective of religion caste and breed, the founders have already declared and set up a Trust for the purposes aforementioned in the town of Cannanore under the name " ISLAHI TRUST " in Cannanore on the day of 15th January 1986.

WHEREAS it is deemed necessary, expedient and proper to reduce to writing the objects and purposes of the Trust as already propounded and the terms and conditions under which and the manner in which the Trust is to be managed and administered as already agreed to by and among the founders.

Now therefore the Deed of Trust Witnesseth as follows:=-

- 1) Name : = The Trust shall be called and known by name of " ISLAHI TRUST ".
- 2) Area of Activity : = The area of activities of the Trust shall be the whole of Cannanore District in Particular and the territory of Indian Union in General.

3) Office := The present Office of the Trust shall be at Cannanore Town. The Trust may establish Sub-Offices and various Centres of its activities at a Place within its area of operation which the Trust may decide.

4) Aims and Objects:= The aim and object of the Trust shall be to provide Charities, to Cater to educational and economic needs of indigent and weaker sections of the people, propagation and advancement of culture, morality and ethics, dissemination of knowledge for practice and observance by the people on ethics morality and culture irrespective of religion, cast and creed, For the implimentation of the above objects and purposes, the Trust shall devolve itself, engage in and strive for,

- a) Establishment of centres of study on ethics and culture and publication of books and periodicals aimed at educating the masses on those subjects.
- b) Setting up cultural Centres and Prayer halls.
- c) Establishment of educational institutions for technical, technological and job- oriented studies as also on other subjects:=-
- d) Providing Scholarships, stipends and such other financial assistance for education of indigent people.
- e) Establishment of business, Industries and factories to provide employment to unemployed people and ~~banking in real estate and~~ to utilise and earmark profits, if any earned therefrom only for the implimentation of all or any of the objects and propose herein envisaged;
- f) Rendering financial assistance to poor and indigent families for conducting marriages.
- g) Organization of Seminars, study classes, discussion and lectures among the people.
- h) Maintenance and running of libraries and reading rooms;

- 1) Providing facilities for adult education.
- j) Helping Widows and women in penury for their livelihood.
- k) Establishment of hospitals dispensaries and clinics for giving free medical aid to the poor;
- l) Running and maintenance of orphanages;
- m) Rendering of services analogous to the above and those that may be decided upon from time to time.
- 5) In the event of dissolution, the Trust properties will vest with the Kerala Nadvathul Mujahideen (Regd) Calicut, an Islahi Organization in Kerala or with the Kerala State Wakf Board if the former ceases its operation and functions.
- 6) Trustees:- A Board of Trustees Called " ISLAHI TRUST " is hereby constituted. The founders shall be the Life - members of the said Trust Board.
- 7) A sum of Rs.8000/= (Eight thousand only) made up on Contribution given by the Founders at the rate of Rs.1000/= (One thousand only) each shall for the time being constitute the Trust Fund and the said amount ~~xxx~~ and all other amounts which may be collected or acquired by the Trust shall be administered for the purpose of Trust.
- 8) The Trust shall sustain itself on and its objects and activities implimented by public subscriptions, grants, donations, gifts, endowments and presents acquired, obtained and collected from all sections of People and all quarters inland and foreign. It shall be lawful for the Trust to receive and accept grants gifts and dispositions of properties in its favour from all sources subject to terms and limitations which the Board approves of.
- 9) It shall be competent for the Trust Board to frame its own bye-laws, Rules and regulations defining its powers, privilege and functions as also the powers privileges and functions of its

Officers for the enlargement of the Strength of its members, prescribe qualifications for inducting new Trustees as also ordinary members of the Trust, for filling up vacancies caused by death or resignation of any Trustee of the Board, convening of the meeting of the Trust Board as also of the ordinary members, constitution of Sub- Committees to deal with any matter or matters and all other matters incidental to the management and administration of the Trust and all its activities envisaged hereunder. All these Rules and Regulations and Bye-laws to be made and approved by the Trust Board shall form part of and shall be deemed to have been incorporated in this Deed.









10. The Ultimate authority and power over all the affairs of the Trust and its agencies shall vest in and be under the Control and superintendence of the Trust Board.

11.) If any difference of opinion arises on any matter touching the interpretation of this deed or matters relating to administration of the Trust or relating to the objects and purposes of the Trust or matters incidental thereto, the decision of the Trust Board as all such matters shall be final and binding.

12) If any difference of opinion arises on any matter touching the interpretation of laws of Islam, the decision of the Kerala Jam - Iyyathul Ulama, (Regd) will be final and binding.

13) The provisions of the deed shall not be varied, modified or deleted or amended unless than four fifth of members of Board concur in such change in a meeting specially convened for the purpose and the same is recorded in the minutes of those meetings. All such amendments modifications deletations or variation shall be subject to the approval of the Commissioner of Income Tax, Kerala.






1. These Rules shall be called the ISLAHI TRUST RULES .
2. It shall come into force on and from this the 15th of
January 1986.
3. These Rules and Bye-laws shall form part of the Deed of
Trust and shall be deemed to have been incorporated therein.

11. (1) THE STRENGTH OF THE BOARD OF TRUSTEES:-

The founders of the Trust as per the Deed of Trust aforesaid
along with the persons who have been nominated to the Trust Board
shall together constitute the Trustees of the Trust Board. The
said strength of the Trust Board may be enlarged by the Trust
Board as per the decision taken by it from time to time.

2. QUALIFICATIONS TO BE THE TRUSTEES OF THE BOARD:

Any citizen of India who have attained 25 years of age
who has not been convicted for any offence of a serious nature
or who is not of a character involving moral turpitude shall
be eligible to be appointed or nominated as a Trustee of the
Board. Any of the Trustee incurring any disqualifications
as aforesaid shall be incompetent to hold the position of a
Trustee and shall cease to be the trustee. The decision of the
Board of Trustees regarding the incompetency of the trustee shall
be final in the matter. The Ultimate authority to decide as to
the Qualifications of a person intended to be taken as a Trustee

of the Board shall be the Board of Trustees and such membership shall be decided upon by a three-fourth majority of the Board of Trustees. The decisions of the Board as aforesaid shall not be called into question by ~~any~~^{any} person or authority or before any court or tribunal.

III. (1) OFFICE BEARERS :=

The office bearers of the Trust Board shall hold office for a period of three years. At the end of each such term, fresh elections to elect new office bearers shall be conducted by the Trust Board and such office bearers shall be elected from among the Trustees of the Trust Board.

(2) DUTIES AND FUNCTIONS OF THE OFFICE BEARERS.

a) Chairman : The Chairman will preside over the Board Meeting and shall have the power of superintendence over all the affairs and administration of the Trust.

b) Vice - Chairman := In the absence of the Chairman, the Vice Chairman, shall preside over the meetings of the Board and attend to other duties and functions of the Chairman.

c) Secretary := The day - to - day administration and management of the affairs of the Trust shall be performed by the Secretary In case of exigency, the Secretary may, in cases relating to the administration of the Trust, take decisions relating to and implement the same consistent only with the objects of the Trust and all such acts shall be got ratified before the Board within two weeks and any such act, without the satisfaction of the Board shall not be valid and binding on the Trust and any such acts is given effect to, the same shall be liable to be cancelled by the Board, Moveable or immovable properties to be acquired by purchase or on

lease or in any other manner in the name of the Secretary for and on behalf of the Trust. He shall also have the power to deal with the properties, or take income with respect thereto, to represent the Trust in meeting by or against the Trust before courts, Tribunals, or other authority, effect sale of movable or immovable properties belonging to the Trust with the previous sanction of the Board. He shall maintain accounts of all the income and expenditure of the Trust and make all these accounts available for inspection by the other Trustees of the Board and get them audited, and passed before the Board, deposit all monies over and above Rs.1000/= in any Bank of repute and the Bank account will be operated by the chairman and secretary jointly.

d) Assistant Secretary :-

The Asst. Secretary shall render all help to the Secretary in the discharge of his functions and discharge the functions of the secretary in his absence on authorisation in writing to the above effect by the Secretary.

Powers and Functions of the Board.

The powers and functions of the Board shall be those enumerated in the Deed of Trust. Any classification with regard to those powers and functions or their ^{amplification} and conferment of any other powers function or privileges apart from those contained in the Deed of Trust shall be as may be decided by the Trust Board.

Meetings of the Board :-

There shall be a meeting of the Board at least every quarter. Notice of every meeting shall be sent by the Secretary to each
