
7. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.

8. Other conditions are enclosed as per Annexure 'A'.

9. **Special conditions to be complied within three months:-**

- The school is required to appoint sufficient no. of qualified and trained teachers including librarian and PET to maintain section teacher ratio 1:1.5 for each level.
- The school is required to ensure that pay-scales, DA and other admissible allowances are being paid at par with the corresponding categories of employees working in the State Govt. Schools as per Affiliation Bye-laws of the Board and disburse the salary through Bank & also submit photocopy of acquittance roll after complying with the above condition.
- The school is required to ensure that no staff member may be appointed / continued in the services of the school who has attained the age of superannuation.
- The School Managing Committee is required to be reconstituted having each of 02 parents representative, teacher representatives and 02 Principals of affiliated schools preferably of Kendriya Vidyalaya / Jawahar Navodaya Vidyalaya.


